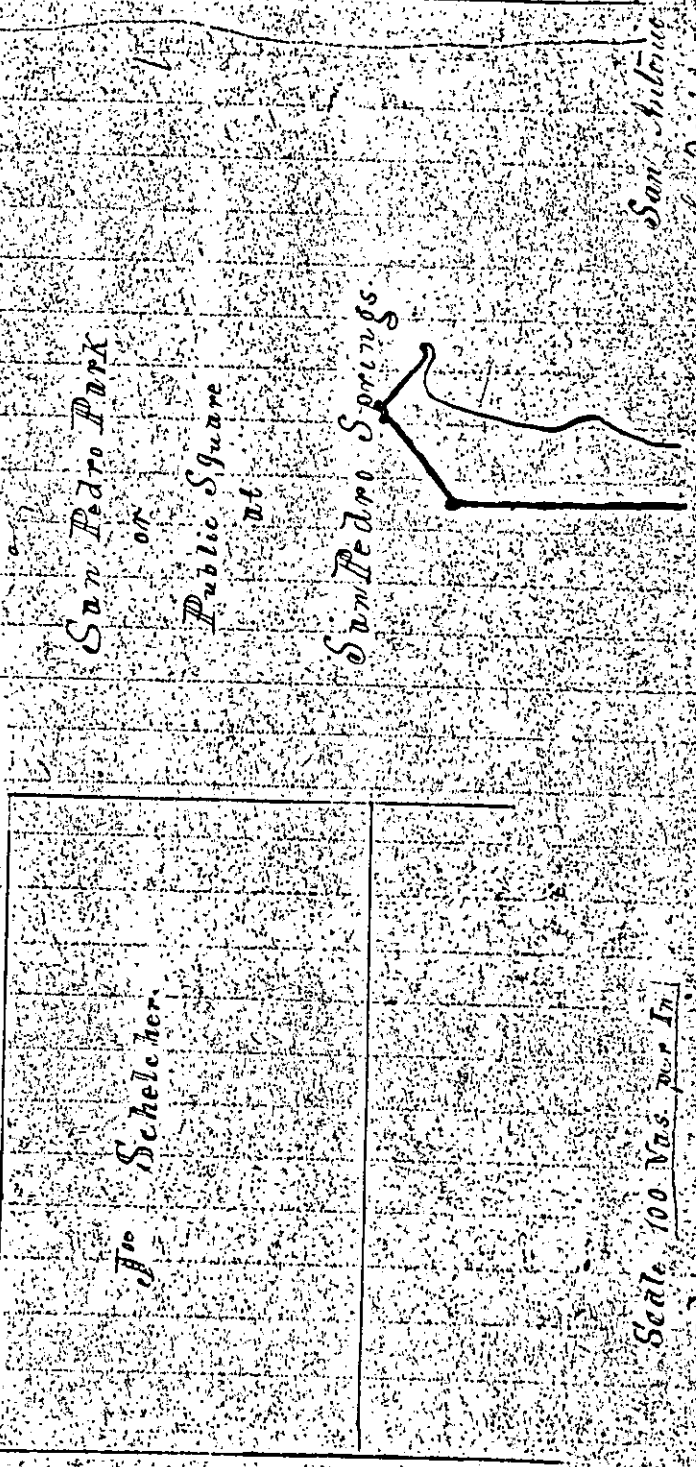

owners being duly joined by their husbands) to-wit: Louisa Graves, formerly Post, wife of Mrs P. Graves, (herein acting by and through her said husband her agent and Attorney in fact by power of attorney duly filed for Record in Bexar County) - secondly Helen Robinson, formerly Post, wife of Frank J. Robinson - thirdly Henry P. Post - fourthly Marion Post (said Helen Robinson and husband, said Henry P. Post and Marion Post acting by and through their brother and Attorney in fact James Post duly authorized by Power of Attorney, filed for Record in Bexar County) and fifthly James Post having agreed to a partition and division among us of lots Nos. 8 and No. 9 in Range No. 11, District No. 3 of the town tract of the City of San Antonio, Bexar County, Texas, lying North and North-West of the San Pedro Spring Reserve, touching the same at its N.W. corner and at its North boundary line - and having in pursuance thereof subdivided said two lots as is more fully shown by the plat of G.
