<u>Traffic Islands:</u> No change since last month.

<u>Large-area Rezoning:</u> Cheryl: city reviewing each property for incorrect zoning. Last year AV had assessed all properties and drafted spreadsheet to discuss with DSD. Spreadsheet needs updating (Erin). City will provide us their list against which we review ours and discuss. The city's process is slow due to COVID and lack of staff and predicted to start up in January.

New Business

<u>Contreras Fund:</u> Cheryl will seek committee participation at Jan. GA on two issues: 1.) as there are no formal constraints on the funds, developing informal constraints based on the deceased's interests in life, specifically the neighborhood and gardening. 2.) moving the fund to a money market.

<u>Proposed 2022 Meeting Schedule</u>: Cheryl will contact Mark Twain to schedule Jan.-May. Councilman Bravo is invited to Jan. GA. Board meetings will continue at 4 p.m. Sunday. Matt moved to approve; Mary seconded.

<u>519 W. King's Hwy</u>: Homeowner sent variance on a very small lot to BOA, asking for a variance from a normal size lot to add two feet to side and back fences. Approved with DSD and Tech Committee

recommendation. However, AVNA and the neighbors did not approve, so the homeowner stated she would provide more justification. Cheryl asked DSD for continuance until 10 Jan. Felice DeNovo asked to provide more information by Dec 20 to give TC time to review

<u>Railroad Quiet Zone</u>: Cheryl will determine where discussion stands with D1 expanding QZ; previously it was not feasible by Hickman due to configuration of streets.
