After getting a brief introduction to the engagement mechanism—an activity with an intriguing name, Sueños of San Pedro Springs Park-we're excited to hear your ideas and see the process and to have this unexpected opportunity to show more love for the park! Hawthorne Farr, Beacon Hill neighbor and Chief Development Officer for Big Brothers Big Sisters, will also be joining us to talk about the positive impact of 1:1 mentoring. He's a Big Brother himself as of 1 year and he'll be picking up

The DRAFT Transit Oriented Development ordinance is also on the agenda. The plan for TOD is to spur walkable, multi-modal, mixed-use development along VIA's Advanced Rapid Transit (ART) corridors, like the ones slated for San Pedro Ave. and Fredericksburg. The final TOD plan that gets adopted has the potential to change land use and zoning up to a quarter mile from any ART corridor. That's right! Though I would guess

Anyone wishing to launch an ART corridor opposition should come to the meeting with their proposal for consideration and vote by the Assembly. Otherwise, come anyway to hear from neighbor David Bogle who has stepped up to represent AVNA on the TOD plan development committee; he will provide a summary of the status of the plan to date, opportunities for

New Neighborhood Plan for Alta Vista, Beacon Hill, and 10 Other Neighborhoods

CoSA will commence this Summer the development of the Near North Community Plan (NNCP). This plan will replace the Midtown Neighborhoods Plan which was developed in the late nineties. The MNP was an extensive process that led to the adoption of Alta Vista's Neighborhood Design Guidelines and other improvements in the neighborhoods that participated. The new NNCP will encompass 11 neighborhood including Alta Vista and Beacon Hill; its framework includes Land Use, Housing, Economic Development, Mobility, Amenities, Public Space, and Focus Area/Corridors. Like the MNP back in 2000, the NNCP is an opportunity to envision new projects in our neighborhood. Perhaps pedestrian and bike lane improvements along Flores connecting to the park or to Mark Twain? An art corridor? Or perhaps long-term improvements for the park? What else can you think of?

The NNCP development process will kick-off this Summer and our new Board Member Melissa Enriquez will represent AVNA; at the September meeting, she'll brief the General Assembly on the status and a plan for gathering your ideas. We'll also be keeping a close eye on how the new NNCP and TOD plan overlap/intersect. If you have questions or idea, contact avna@altavistana.org

Then, David's proposal will be reviewed by the regional scouting governing body for adherence to Eagle Scout criteria. If given the green light, David will make a more detailed project plan and the project will start in the Fall. AVNA will separately handle similar improvements to the W. Kings Hwy traffic island. Hands are always needed for traffic island work days and there hasn't been one in years as far as we know.
